**RESOLUTION DECLARING LOWEST CALCULATED RESPONSIVE BID
AND RECOMMENDING AWARD OF CONTRACT**

WHEREAS, the Department of Social Welfare and Development - Cordillera Administrative Region (DSWD-CAR) through the various end-users/programs planned for the Procurement of the project, **Purchase and Delivery of Crossover Utility Vehicle** with an Approved Budget for the Contract (ABC) amounting to One Million Four Hundred Eighty Thousand Pesos (Php 1,480,000.00);

WHEREAS, Republic Act 9184, otherwise known as the Government Procurement Reform Act, in its Implementing Rules and Regulations under Section 10, provides that "all procurement shall be done through competitive bidding, except as provided in Rule XVI";

WHEREAS, in consonance with the Republic Act 9184 and its Implementing Rules and Regulations, a Project Procurement Management Plan (PPMP) for the project was incorporated in CY2022 Annual Procurement Plan (APP) of the Field Office adopting Public Bidding as mode of Procurement;

WHEREAS, the project, after two (2) failed public biddings, was procured through Negotiated Procurement-Two Failed Biddings;

WHEREAS, the Bids and Awards Committee (BAC) through the BAC Secretariat advertised the Invitation to Bid from **12 May 2022 to 19 May 2022** at DSWD-CAR website, Philippine Government Electronic Procurement System (PhilGEPS) and posted at DSWD-CAR Bulletin Board located at the main entrance of the Field Office;

WHEREAS, in reference to BAC Resolution no. 30 S. 2022, the said bidder was declared as the **Single Calculated Bid** for passing the bid evaluation process which was presented on **19 May 2022** and the BAC directed the TWG for the conduct of post-qualification;

WHEREAS, a post-qualification was conducted with of **Blue Oval Automotive Corporation - Ford Metro Baguio** and the TWG presented the result as follows:

- The bidder has valid and authentic eligibility documents;
- Complied with the Latest Income and Business Tax Returns through eFPS;
- Assured to adhere to the technical requirements and conditions of the project;
- Has enough contracting capacity to undertake the project;

CONTRACT AGREEMENT

THIS AGREEMENT made on the 02 day of June 2022 between **Department of Social Welfare and Development – Cordillera Administrative Region** represented by **DIR. ARNEL B. GARCIA, CESO II**, Regional Director with office address at 40 North Drive, Baguio City, Philippines (hereinafter called “the Entity”) of the one part and **Blue Oval Automotive Corporation – Ford Metro Baguio** represented by **MR. JAN DANIEL M. RIMANDO, Officer-In-Charge** with office address at Central Tuba, Benguet, Philippines (hereinafter called “the Supplier”) of the other part;

WHEREAS, the Entity invited Bids for certain goods and services, particularly **Purchase and Delivery of Crossover Utility Vehicle for DSWD-CAR** under **Negotiated Procurement – Two Failed Biddings (NP 2022-DSWD-CAR-04)** and has accepted a Bid by the **Supplier** for the supply of those goods and services with contract amount of **One Million Four Hundred Fifty Thousand Pesos (Php1,450,000.00)**, (hereinafter called “the Contract Price”);

NOW THIS AGREEMENT WITNESSETH AS FOLLOWS:

1. In this Agreement words and expressions shall have the same meanings as are respectively assigned to them in the Conditions of Contract and Annex A: Duties and Responsibilities referred to.
2. The following documents as required by the 2016 revised Implementing Rules and Regulations of Republic Act No. 9184 shall be deemed to form and be read and construed as integral part of this Agreement, viz.:
 - i. Philippine Bidding Documents (PBDs);
 - i. Schedule of Requirements;
 - ii. Technical Specifications and Terms of Reference;
 - iii. General and Special Conditions of Contract; and
 - iv. Supplemental or Bid Bulletins, if any
 - ii. Winning bidder’s bid, including the Eligibility requirements, Technical and Financial Proposals, and all other documents or statements submitted;

Bid form, including all the documents/statements contained in the Bidder’s bidding envelopes, as annexes, and all other documents submitted (e.g., Bidder’s response to request for clarifications on the bid), including corrections to the bid, if any, resulting from the Procuring Entity’s bid evaluation;
- iii. Performance Security;
- iv. Notice of Award of Contract; and the Bidder’s conforme thereto; and





- v. Other contract documents that may be required by existing laws and/or the Procuring Entity concerned in the PBDs. **Winning bidder agrees that additional contract documents or information prescribed by the GPPB that are subsequently required for submission after the contract execution, such as the Notice to Proceed, Variation Orders, and Warranty Security, shall likewise form part of the Contract.**
3. In consideration for the sum of **One Million Four Hundred Fifty Thousand Pesos (Php1,450,000.00)** or such other sums as may be ascertained, **Blue Oval Automotive Corporation – Ford Metro Baguio** agrees to provide the goods and services for the **Purchase and Delivery of Crossover Utility Vehicle for DSWD-CAR** under **NP 2022-DSWD-CAR-04** in accordance with his/her Bid.
4. The **Department of Social Welfare and Development – Cordillera Administrative Region** agrees to pay the above-mentioned sum in accordance with the terms of the Bidding.
