WHEREAS, the Department of Social Welfare and Development-Cordillera Administrative Region (DSWD-CAR) has appropriations for procurement of the project, BOARD AND LODGING FOR THE SKILLS ENHANCEMENT AND INTEGRITY MANAGEMENT PROGRAM TRAINING FOR SLP MPDOS, with an Approved Budget for the Contract (ABC) amounting to TWO HUNDRED THREE THOUSAND PESOS (P203,000.00) ONLY and within Annual Procurement Plan (APP) 2023 through Negotiated Procurement under LEASE OF VENUE;

WHEREAS, on the 1st day of March 2023, Request for Quotations (RFQ) were transmitted for floating to suppliers;

WHEREAS, on the 6th day of March 2023 at 12:00NN was the set deadline for the submission of quotations;

WHEREAS, upon opening of the Request for Quotations on the 14th day of March 2023 findings were listed on Annex A;

WHEREAS, upon evaluation by the Bids and Awards Committee (BAC), CHALET BAGUIO, emerged to be the only bidder with quotation. Thus, was subject for rating factor as to compliance with the technical specifications and other requirements of the project and verification of amount as read vs. as calculated;

WHEREAS, on the rating factor submitted, CHALET BAGUIO, surpassed the 90% passing rate and garnered 100.00%. Further, the same bidder acknowledged the error on the amount as calculated vs. as read and expressed that amount as read should be followed. Amount as read to be awarded then, was agreed upon by the BAC as it is more efficient for the project;

NOW, THEREFORE, foregoing premises considered, We, the Members of the Bids and Awards Committee, hereby RESOLVED as it is hereby resolved to declare CHALET BAGUIO as the SINGLE CALCULATED RESPONSIVE QUOTATION and recommend to the Regional Director the award of contract amounting to TWO HUNDRED TWO THOUSAND SIX HUNDRED TWENTY FIVE PESOS (P202,625.00) ONLY inclusive of all applicable taxes and fees for the project, BOARD AND LODGING FOR FOR THE SKILLS ENHANCEMENT AND INTEGRITY MANAGEMENT PROGRAM TRAINING FOR SLP MPDOS, for approval of the Head of Procuring Entity.
