- 3. All entries must be typewritten/printed/longhand. Any erasure in the quotation must be countersigned by the bidder/ representative,
- otherwise quotation will be rejected. 4. The Procuring Entity may give due preference to goods being offered with green component.
- 5. If necessary, the BAC through the TWG, may require an occular inspection of the venue/place of business/goods being offered.

- 7. Price validity shall be for a period of 120 calendar days from RFQ Opening of the BAC until confirmation of Purchase Order by the




