

INVITATION FOR NEGOTIATED PROCUREMENT – TWO FAILED BIDDINGS

PURCHASE OF BRAND NEW SERVICE VEHICLE

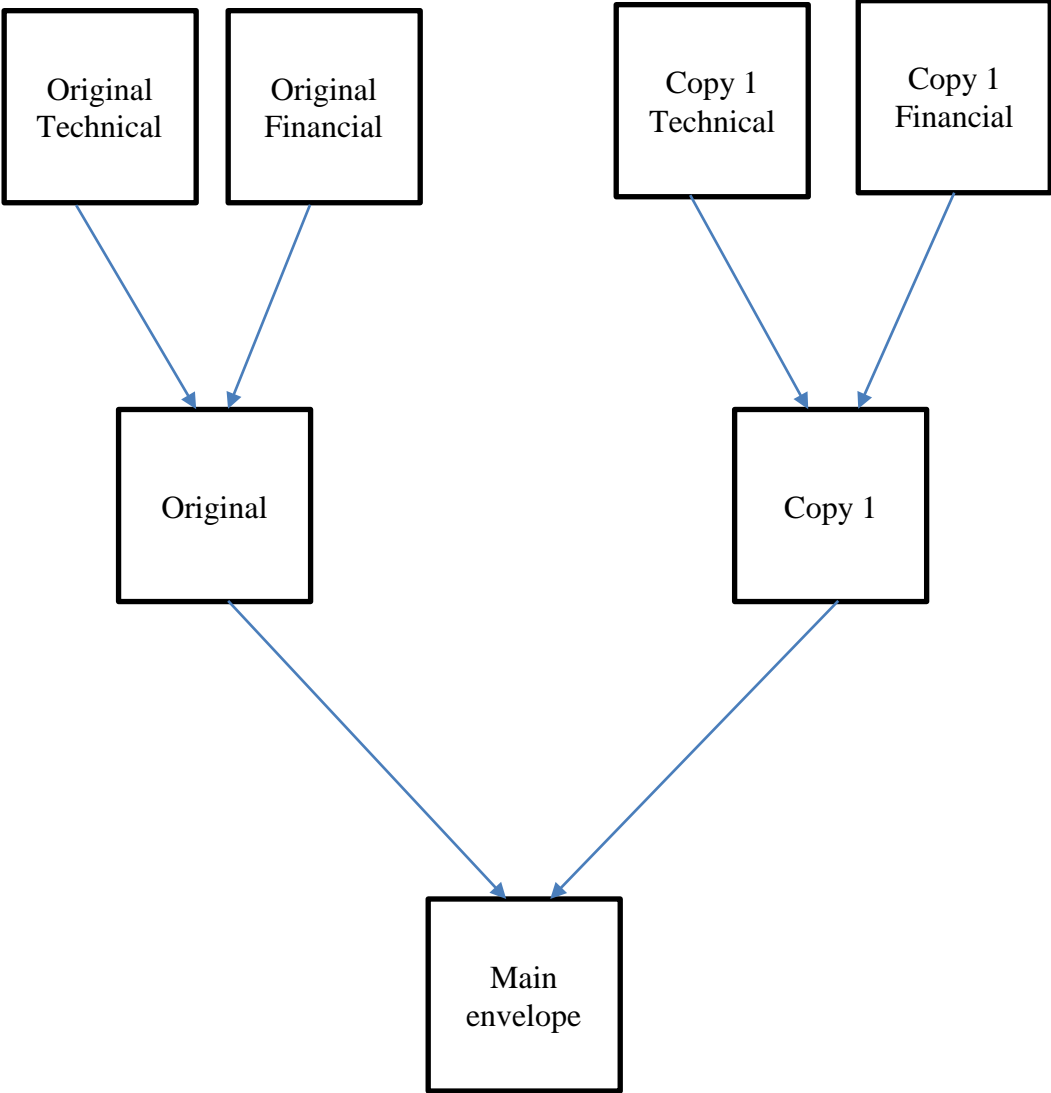
