CONTRACT AGREEMENT

THIS AGREEMENT made the ______ day of January 2021 between Department of Social Welfare and Development – Cordillera Administrative Region represented by LEO L. QUINTILLA, Regional Director with office address at 40 North Drive, Baguio City, Philippines (hereinafter called "the Entity") of the one part and GABLETS CATERING SERVICES represented by MS. LANALYN L. CABJUAN, Proprietress with office address at 145 Military Cut-Off, Baguio City, Philippines (hereinafter called "the Supplier") of the other part;

WHEREAS, the Entity invited Bids for certain goods and services, particularly Catering Services for Various DSWD-CAR Advocacy Activities for 2021 (ITB 2021-DSWD-05) and has accepted a Bid by the Supplier for the supply of those goods and services in the sum of One Million Six Hundred Ninety-Nine Thousand Six Hundred Seventy Pesos (Php 1,699,670.00), (hereinafter called "the Contract Price").

WHEREAS, the Department of Social Welfare and Development - Cordillera Administrative Region (DSWD-CAR) planned for the procurement of the project - Catering Services for Various DSWD-CAR Advocacy Activities for 2021 (ITB 2021-DSWD-CAR-05) with an Approved Budget for the Contract (ABC) to be funded by the General Appropriations Act of 2021 with the respective amount of:

- WHEREAS, Republic Act 9184, otherwise known as the Government Procurement Reform Act, in its Implementing Rules and Regulations under Section 10, provides that "all procurement shall be done through competitive bidding, except as provided in Rule XVI";
- WHEREAS, in consonance with the Republic Act 9184 and its Implementing Rules and Regulations, a Project Procurement Management Plan (PPMP) for the project was incorporated in CY2021 Indicative Annual Procurement Plan (APP) of the Field Office adopting Public Bidding as mode of Procurement;
- WHEREAS, the GPPB Circular 06-2019 dated July 17, 2019, authorized the conduct of Early Procurement Activities (EPA) for goods to be delivered and implemented in the following fiscal year pending approval of funding sources;
- WHEREAS, the Bids and Awards Committee (BAC) through the BAC Secretariat advertised the Invitation to Bid from November 11, 2020 to 9:30am of December 02, 2020 at DSWD-CAR website, Philippine Government Electronic Procurement System (PhilGEPS) and posted at DSWD-CAR Bulletin Board located at the main entrance of the Field Office;
- WHEREAS, in response to the said advertisement, the following bidders purchased bid documents and submitted a bid/proposal within the set deadline for the submission of bids with cut-off time at 9:30am of December 2, 2020, to wit:

WHEREAS, the TWG composed of 1) Dazon B. Hangdaan/CBS, 2) Erwin B. Dado/LDS, 3) Beverly T. Gama/PS, 4) Simphel T. Lucaben/FMD, and 5) Jami A. Bambilla/LDS conducted a post-qualification inquiry with GABLETS CATERING SERVICES. Thus, the TWG was able to verify that said bidder was compliant with all the prescribed requirements. Therefore, based on the submitted post qualification report, the said bidder was found to be:

- Legally, technically and financially compliant
- Compliant to all terms and conditions required for the project
- Over-all assessment: Responsive

WHEREAS, the BAC deliberated the Post-Qualification Report and found merit to the findings of the TWG and unanimously declared GABLETS CATERING SERVICES as the Lowest Calculated and Responsive Bidder (LCRB) for Lot 1 and the Single Calculated Bidder (SCRB) for Lot 2.
