CONTRACT AGREEMENT

THIS AGREEMENT made the 27th day of January 2021 between Department of Social Welfare and Development – Cordillera Administrative Region represented by LEO L. QUINTILLA, Regional Director with office address at 40 North Drive, Baguio City, Philippines (hereinafter called "the Entity") of the one part and COLLEEN'S FARM AND POULTRY SUPPLY represented by MR. EDWIN C. GUILLERMO, Proprietor with office address at Centro West, Allacapan, Cagayan, Philippines (hereinafter called "the Supplier") of the other part;

WHEREAS, the Entity invited Bids for certain goods and services, particularly Purchase of Rice for the 11th Cycle Supplementary Feeding Program in Kalinga, Baguio City and Benguet – Lot 1 and Lot 2 under ITB 2021-DSWD-CAR-07 and has accepted a Bid by the Supplier for the supply of those goods and services with an aggregate contract amount of Three Million Thirty-Seven Thousand Five Hundred Twenty-Five Pesos (Php 3,037,525.00), (hereinafter called "the Contract Price").

Winning bidder agrees that additional contract documents or information prescribed by the GPPB that are subsequently required for submission after the contract execution, such as the Notice to Proceed, Variation Orders, and Warranty Security, shall likewise form part of the Contract.
