The Bid Opening was called to order by Ms. Rina Claire L. Reyes, Vice Chairperson, Bids and Awards Committee (BAC) at 10:00AM for the project, Purchase and Delivery of Personal Protective Supplies for DSWD-CAR Staff – CY 2021 with an Approved Budget for the Contract amounting to Two Million Fifty-Five Thousand Nine Hundred Fifty-Five Pesos Only (Php 2,055,955.00).
