## -NEGOTIATED PROCUREMENT- LEASE OF VENUE-BOARD AND LODGING FOR LEARNING AND DEVELOPMENT INTERVENTIONS FOR PANTAWID PAMILYA STAFF AND STAKEHOLDERS FOR CY 2020 — TRAINING ON THE

USE OF PANTAWID PAMILYA INFORMATION SYSTEMS FOR POOS AND SWOS LOW

- WHEREAS, the Department of Social Welfare and Development-Cordillera Administrative Region (DSWD-CAR) has been granted appropriations for the BOARD AND LODGING FOR LEARNING AND DEVELOPMENT INTERVENTIONS FOR PANTAWID PAMILYA STAFF AND STAKEHOLDERS FOR CY 2020 with an Approved Budget for the Contract (ABC) of Two Hundred Eighty-Eight Thousand Pesos Only (P288,000.00);
- WHEREAS, in consonance with the Republic Act 9184 and its Implementing Rules and Regulations, a Project Procurement Management Plan (PPMP) which has been consolidated into the Annual Procurement Plan (APP) is in order for procurement of the programs, activities and projects for 2020;
- WHEREAS, in consonance with the Republic Act 9184, otherwise known as the Government Procurement Reform Act, in its Implementing Rules and Regulations under Section 10, provides that "all procurement shall be done through competitive bidding, except as provided in Rule XVI";
- WHEREAS, Section 48.1 of the IRR of the above cited act stipulates that "subject to prior approval of the head of procuring entity, and whenever justified by the conditions provided in this Act, the procuring entity may, in order to promote economy and efficiency, resort to any of the alternative mode of procurement;
- WHEREAS, section 53.9 of the Revised Implementing Rules and Regulations (IRR) of the RA 9184 or otherwise known as the Government Procurement Reform Act of 2002 allows the procuring entity cresort to Negotiated Procurement –LEASE OF VENUE;
- WHEREAS, on the 7th day of January 2020, Request for Quotations were transmitted to the end user;
- WHEREAS, on 10<sup>th</sup> day of January 2020 at 6pm was the set deadline for the submission of quotations and one (1) price quotation was obtained from CIUDAD FERNANDINA HOTEL. On the other hand, HOTEL LUNA, CASA RICA HOTEL, CORDILLERA INN VIGAN CITY and VIGAN PLAZA HOTEL were not able to submit their price quotations. In pursuant to the 2016 Revised IRR of RA 9184 under Lease of Venue and Small Value Procurement, the receipt of at least one (1) price quotation is sufficient to proceed with the evaluation thereof;
- WHEREAS, upon opening of the Request for Quotation held on the 14<sup>th</sup> day of January 2020, findings were listed in the summary of quotations below:
