-NEGOTIATED PROCUREMENT- EMERGENCY CASES-

PURCHASE AND DELIVERY OF FOOD SUPPLIES FOR EMERGENCY RELIEF OPERATION

WHEREAS, the Department of Social Welfare and Development-Cordillera Administrative Region (DSWD-CAR) has been granted appropriations for **PURCHASE AND DELIVERY OF FOOD SUPPLIES FOR EMERGENCY RELIEF OPERATION** with an Approved Budget for the Contract (ABC) of Two Hundred Forty-Four Thousand Two Hundred Pesos Only (P244,200.00);

WHEREAS, in consonance with the Republic Act 9184 and its Implementing Rules and Regulations, a Project Procurement Management Plan (PPMP) which has been consolidated into the Annual Procurement Plan (APP) is in order for procurement of the programs, activities and projects for 2020;

WHEREAS, in consonance with the Republic Act 9184, otherwise known as the Government Procurement Reform Act, in its Implementing Rules and Regulations under Section 10, provides that "all procurement shall be done through competitive bidding, except as provided in Rule XVI";

WHEREAS, Section 48.1 of the IRR of the above cited act stipulates that "subject to prior approval of the head of procuring entity, and whenever justified by the conditions provided in this Act, the procuring entity may, in order to promote economy and efficiency, resort to any of the alternative mode of procurement;

WHEREAS, under Section of 53.2 of the same IRR, Negotiated Procurement through the use of Emergency Cases can be used in cases of imminent danger to life or property during the state of calamity, or when time is of the essence arising from natural or man-made calamities or other causes where immediate action is necessary to prevent damage to or loss of life or property, or to restore vital public services;

WHEREAS, Proclamation No. 929 declared the entire Philippines to be under State of Calamity for a period of six (6) months due to the sharp increase of COVID-19 cases throughout the country. The same proclamation imposes the "Enhanced Community Quarantine" throughout Luzon;

WHEREAS, on 1st day of June 2020, the Modified General Community Quarantine (MGCQ) was imposed for the Cordillera Administrative Region. Thus, a large number of the population is still affected by the rules and regulations provided thereof. Therefore, the government is still mandated to subsidize the basic needs of those who are greatly affected by such circumstance;

WHEREAS, the Department of Social Welfare and Development through its Field Offices is mandated to respond to the needs of victims in times of disasters and calamities. Thus, to expedite the procurement of goods and services to respond with the aforementioned circumstances, DSWD-CAR needs to resort with the use of Negotiated Procurement through Emergency Cases;

WHEREAS, on the 19th day of June 2020, Request for Quotation was floated to a supplier that is technical, legal and financial capable namely **TSH CORPORATION**;

WHEREAS, on 22nd day of June 2020 a quotation was received from the abovementioned supplier;

WHEREAS, upon opening of the Request for Quotation held on the 22nd day of June 2020, findings were reflected in the table provided below:

WHEREAS, upon evaluation by the Bids and Awards Committee (BAC), it was observed that the submitted bid amount of **TSH CORPORATION** was lower by .005 centavo than that was calculated by the Agency. Therefore, since the submitted bid price of **TSH CORPORATION** was more advantageous to the government, the BAC resolved that the recommended contract amount will be based on the submitted bid price of **TSH CORPORATION**;

NOW, THEREFORE, foregoing premises considered, We, the Members of the Bids and Awards Committee, hereby **RESOLVED** as it is hereby resolve to recommend to the Regional Director the award of contract to **TSH CORPORATION** which offered an amount of Two Hundred Eighteen Thousand Four Hundred Six Pesos and Thirty-Seven Centavos (P218,406.37) inclusive of all the applicable taxes and fees for the **PURCHASE AND DELIVERY OF FOOD SUPPLIES FOR EMERGENCY RELIEF OPERATION**.
