-NEGOTIATED PROCUREMENT- SMALL VALUE PROCUREMENT-

RADIO PROGRAM FOR FDS ON AIR AND OTHER PROGRAM UPDATES

WHEREAS, the Department of Social Welfare and Development-Cordillera Administrative Region (DSWD-CAR) has been granted appropriations for the **RADIO PROGRAM FOR FDS ON AIR AND OTHER PROGRAM UPDATES** with an Approved Budget for the Contract (ABC) of Ninety Six Thousand Pesos Only (P96,000.00);

WHEREAS, in consonance with the Republic Act 9184 and its Implementing Rules and Regulations, a Project Procurement Management Plan (PPMP) which has been consolidated into the Annual Procurement Plan (APP) is in order for procurement of the programs, activities and projects for 2021;

WHEREAS, in consonance with the Republic Act 9184, otherwise known as the Government Procurement Reform Act, in its Implementing Rules and Regulations under Section 10, provides that "all procurement shall be done through competitive bidding, except as provided in Rule XVI";

WHEREAS, Section 48.1 of the IRR of the above cited act stipulates that "subject to prior approval of the head of procuring entity, and whenever justified by the conditions provided in this Act, the procuring entity may, in order to promote economy and efficiency, resort to any of the alternative mode of procurement;

WHEREAS, section 53.9 of the Revised Implementing Rules and Regulations (IRR) of the RA 9184 or otherwise known as the Government Procurement Reform Act of 2002 allows the procuring entity to resort to Negotiated Procurement – **SMALL VALUE PROCUREMENT**;

WHEREAS, on the 20th day of January 2021, Request for Quotations were transmitted to the End-User. On the same day, bid notice was posted in the PhilGEPS website as mandated in the 2016 Revised IRR of RA 9184 for Request for Quotations with an Approved Budget for the Contract (ABC) of above Fifty Thousand Pesos (Php 50,000.00) under Small Value Procurement and Shopping;


WHEREAS, on the 25th day of January 2021 at 6pm was the set deadline for the submission of quotations wherein one (1) price quotation was received from the bidder namely **MT. PROVINCE BROADCASTING CORP.** On the other hand, **RPN BAGUIO** and **RADYO PILIPINAS** were invited thru email to quote but did not respond to the invitation. In pursuant to the 2016 Revised IRR of RA 9184 under Lease of Venue and Small Value Procurement, the receipt of at least one (1) price quotation is sufficient to proceed with the evaluation thereof;



WHEREAS, upon opening of the Request for Quotations held on the 27th day of January 2021, findings were listed in the summary of quotations below:

WHEREAS, upon evaluation by the Bids and Awards Committee, **MT. PROVINCE BROADCASTING CORP.** emerged to be the lone bidder. Upon further evaluation, the quotation of said bidder was found to be compliant with all the prescribed requirements;

WHEREAS, based on the foregoing, the BAC resolved to declare **MT. PROVINCE BROADCASTING CORP.** as the Single Calculated and Responsive Bidder (SCRB). On the other hand, prior to the issuance of approved Purchase Order, bidder must submit first their CY 2021 updated eligibility documents;
