



BIDS AND AWARDS COMMITTEE RESOLUTION NO. 066 S. 2021

-NEGOTIATED PROCUREMENT- SMALL VALUE PROCUREMENT-

PURCHASE AND DELIVERY OF NON FOOD ITEMS FOR RRCY

- WHEREAS, the Department of Social Welfare and Development-Cordillera Administrative Region (DSWD-CAR) has been granted appropriations for the PURCHASE AND DELIVERY OF NON FOOD ITEMS FOR RRCY with an Approved Budget for the Contract (ABC) of Two Hundred Thirty Thousand Two Hundred Forty Three Pesos Only (₱230,243.00); ¬
- WHEREAS, in consonance with the Republic Act 9184 and its Implementing Rules and Regulations, a Project Procurement Management Plan (PPMP) which has been consolidated into the Annual Procurement Plan (APP) is in order for procurement of the programs, activities and projects for 2021;
- WHEREAS, in consonance with the Republic Act 9184, otherwise known as the Government Procurement Reform Act, in its Implementing Rules and Regulations under Section 10, provides that "all procurement shall be done through competitive bidding, except as provided in Rule XVI";
- **WHEREAS,** Section 48.1 of the IRR of the above cited act stipulates that "subject to prior approval of the head of procuring entity, and whenever justified by the conditions provided in this Act, the procuring entity may, in order to promote economy and efficiency, resort to any of the alternative mode of procurement;
- WHEREAS, section 53.9 of the Revised Implementing Rules and Regulations (IRR) of the RA 9184 or otherwise known as the Government Procurement Reform Act of 2002 allows the procuring entity to resort to Negotiated Procurement SMALL VALUE PROCUREMENT;
- WHEREAS, on the 25th day of January 2021, Request for Quotations were transmitted to the End-User. On the same day, bid notice was posted in the PhilGÈPS website as mandated in the 2016 Revised IRR of RA 9184 for Request for Quotations with an Approved Budget for the Contract (ABC) of above Fifty Thousand Pesos (Php 50,000.00) under Small Value Procurement and Shopping;
- WHEREAS, on the 29th day of January 2021 at 6pm was the set deadline for the submission of quotations wherein three (3) price quotations were received from the bidders namely JSCG ENTERPRISES, OPC, TARILJA ENTERPRISES and ESM LEARNING ENTERPRISES. In pursuant to the 2016 Revised IRR of RA 9184 under Lease of Venue and Small Value Procurement, the receipt of at least one (1) price quotation is sufficient to proceed with the evaluation thereof;
- WHEREAS, upon opening of the Request for Quotations held on the 2nd day of February 2021, findings were listed in the summary of quotations below:

- WHEREAS, upon evaluation by the Bids and Awards Committee, as per Section 32.2.3. (b) of the same IRR, in case of discrepancies between total price per item and unit price for the item as extended or multiplied by the quantity of that item, the latter shall prevail. With this, ESM LEARNING ENTERPRISES emerged to be the lowest bidder. However, to ensure the compliance of the received quotations, the BAC resolved to require post qualification inquiry;
- **WHEREAS**, on the 15th day of February 2021, the post qualification report was presented to the BAC. As per said report, the lowest bidder **ESM LEARNING ENTERPRISES** was found to be compliant with all the prescribed requirements;
- WHEREAS, as per Section 34.4 of the 2016 Revised IRR of RA 9184" If the BAC determines that the bidder with the Lowest Calculated/Bid passes all the criteria for post-qualification, it shall declare the said bid as the LCRB or HRRB, and recommend to the HoPE the award of contract to the said bidder at its submitted bid price or its calculated bid price, whichever is lower". Therefore, the BAC resolved to require

a price verification inquiry with the lowest bidder. On the same day, the price verification inquiry was presented to the BAC. As such, **ESM LEARNING ENTERPRISES** signified that they are willing to accept that the contract amount will be based on the calculated bid price. Thus, the contract amount should be \$\mathbb{P}219,175.00;

WHEREAS, based on the foregoing, the BAC resolved to declare ESM LEARNING ENTERPRISES as the Lowest Calculated and Responsive Bidder (LCRB);

NOW, THEREFORE, foregoing premises considered, We, the Members of the Bids and Awards Committee, hereby RESOLVED as it is hereby resolved to recommend to the Regional Director the award of contract to ESM LEARNING ENTERPRISES which offered an amount of Two Hundred Nineteen Thousand One Hundred Seventy Five Pesos Only (₱219,175.00) inclusive of all the applicable taxes and fees for the PURCHASE AND DELIVERY OF NON FOOD ITEMS FOR RRCY.
