- WHEREAS, the Department of Social Welfare and Development-Cordillera Administrative Region (DSWD-CAR) has been granted appropriations for CATERING SERVICES FOR THE PROVINCIAL PARTNER STAKEHOLDER'S MEETING IN APAYAO with an Approved Budget for the Contract (ABC) of Eighty Thousand Pesos Only (₱80,000.00);
- WHEREAS, in consonance with the Republic Act 9184 and its Implementing Rules and Regulations, a Project Procurement Management Plan (PPMP) which has been consolidated into the Annual Procurement Plan (APP) is in order for procurement of the programs, activities and projects for 202
- WHEREAS, in consonance with the Republic Act 9184, otherwise known as the Government Procurement Reform Act, in its Implementing Rules and Regulations under Section 10, provides that "all procurement shall be done through competitive bidding, except as provided in Rule XVI";
- WHEREAS, Section 48.1 of the IRR of the above cited act stipulates that "subject to prior approval of the head of procuring entity, and whenever justified by the conditions provided in this Act, the procuring entity may, in order to promote economy and efficiency, resort to any of the alternative mode of procurement;
- WHEREAS, section 53.9 of the Revised Implementing Rules and Regulations (IRR) of the RA 9184 or otherwise known as the Government Procurement Reform Act of 2002 allows the procuring entity to resort to Negotiated Procurement SMALL VALUE PROCUREMENT;
- WHEREAS, on 11<sup>th</sup> day of January 2021, Request for Quotations were transmitted to the End-User. On the same day, bid notice was posted in the PhilGEPS website as mandated in the 2016 Revised IRR of RA 9184 for Request for Quotations with an Approved Budget for the Contract (ABC) of above Fifty Thousand Pesos (Php 50,000.00) under Small Value Procurement and Shopping;
- WHEREAS, on 15<sup>h</sup> day of January 2021 at 6PM was the set deadline for the submission of quotations wherein one (1) price quotation was obtained from WALAI RESORT. On the other hand, STAR JEWEL LODGE, and RJ DOMINGO FISH FARM RESORT were invited but did not quote for the procurement at hand. In pursuant to the 2016 Revised IRR of RA 9184 under Lease of Venue and Small Value Procurement, the receipt of at least one (1) price quotation is sufficient to proceed with the evaluation thereof;
- WHEREAS, upon opening of the Request for Quotations held on the 20<sup>th</sup> day of January 2021, findings were listed in the summary of quotations below:

- WHEREAS, upon evaluation by the Bids and Awards Committee (BAC), the quotation of WALAI RESORT was found to be within the ABC. However, upon further assessment, it was observed that said bidder was not able to indicate its compliance to the prescribed specifications.. Further, it was also raised tat said bidder was not yet able to submit its CY 2021 updated eligibility documents. Therefore, to clarify the said concerns, the BAC resolved to require a post qualification inquiry;
- WHEREAS, on 2<sup>nd</sup> day of February 2021, the post qualification report was presented to the BAC. As per said report, WALAI RESORT was verified to be compliant with all the prescribed requirements. However, the processing of its updated CY 2021 eligibility documents were still on process. Therefore, the BAC resolved that pending to the submission of WALAI RESORT's updated eligibility documents, the award of contract for the procurement at hand will be recommended to said bidder;
- WHEREAS, based on the foregoing, the BAC resolved to declare WALAI RESORT as the Single Calculated and Responsive Bidder (SCRB). This is provided that prior to the preparation of Purchase Order, said bidder shall submit first their CY 2021 updated eligibility documents;
