BOARD AND LODGING FOR THE INTEGRATED PROGRAM REVIEW AND EVALUATION WORKSHOP (PREW)

- WHEREAS, the Department of Social Welfare and Development-Cordillera Administrative Region (DSWD-CAR) has been granted appropriations for the BOARD AND LODGING FOR THE INTEGRATED PROGRAM REVIEW AND EVALUATION WORKSHOP (PREW) with an Approved Budget for the Contract (ABC) of Fifty-One Thousand Nine Hundred Pesos Only (₱51,900.00);
- WHEREAS, in consonance with the Republic Act 9184 and its Implementing Rules and Regulations, a Project Procurement Management Plan (PPMP) which has been consolidated into the Annual Procurement Plan (APP) is in order for procurement of the programs, activities and projects for 2021;
- WHEREAS, in consonance with the Republic Act 9184, otherwise known as the Government Procurement Reform Act, in its Implementing Rules and Regulations under Section 10, provides that "all procurement shall be done through competitive bidding, except as provided in Rule XVI";
- WHEREAS, Section 48.1 of the IRR of the above cited act stipulates that "subject to prior approval of the head of procuring entity, and whenever justified by the conditions provided in this Act, the procuring entity may, in order to promote economy and efficiency, resort to any of the alternative mode of procurement;
- WHEREAS, section 53.10 of the Revised Implementing Rules and Regulations (IRR) of the RA 9184 or otherwise known as the Government Procurement Reform Act of 2002 allows the procuring entity to resort to Negotiated Procurement LEASE OF VENUE;
- WHEREAS, on 9th day of December 2020, Request for Quotations were transmitted to the End-User;
- WHEREAS, on 14th day of December 2020 at 6PM was the set deadline for the submission of quotations wherein one (1) price quotation was obtained from CITY TRAVEL HOTEL. On the other hand, CITYLIGHT PROPERTIES DEVELOPMENT CORP., 5R HOLDINGS, INC./RIDGEWOOD HOTEL, and NEWTOWN PLAZA HOTEL CORP., were invited bud did not quote for the procurement at hand. In pursuant to the 2016 Revised IRR of RA 9184 under Lease of Venue and Small Value Procurement, the receipt of at least one (1) price quotation is sufficient to proceed with the evaluation thereof;
- WHEREAS, upon opening of the Request for Quotations held on the **18th day of December 2020**, findings were listed in the summary of quotations below:

- WHEREAS, upon evaluation by the Bids and Awards Committee (BAC), the quotation of CITY TRAVEL HOTEL was found to be within the ABC. However, during the bid opening, the Rating Factor of CITY TRAVEL HOTEL was not yet available. Hence, the BAC resolved to require first the tabulation of rating factor for CITY TRAVEL HOTEL;
- WHEREAS, on 6th day of January 2021, the rating factor was presented to the BAC. As per said document, CITY TRAVEL HOTEL passed the 90% passing rate wherein it garnered 97% rating factor from the End-User;
- WHEREAS, based on the foregoing, the BAC resolved to declare CITY TRAVEL HOTEL as the Single Calculated and Responsive Bidder (SCRB);
