Contract Agreement Form for the Procurement of Goods

CONTRACT AGREEMENT

THIS AGREEMENT made the ____ day of ____ 2021 between the Department of Social Welfare and Development – Cordillera Administrative Region (DSWD-CAR) of #40 Northdrive Baguio City of the Philippines (hereinafter called "the Entity") of the one part and Zymed Medical Distributor of Lot 9 BLK. A Irisville Subd., Upper Pear St., Irisan, Baguio City of the Philippines (hereinafter called "the Supplier") of the other part;

WHEREAS, the Entity invited Bids for certain goods and ancillary services, particularly Purchase and Delivery of Personal Protective Supplies for DSWD-CAR Staff – CY 2021 and has accepted a Bid by the Supplier for the supply of those goods and services in the sum of Nine Hundred Ninety-Four Thousand Seven Hundred Sixty-Two Pesos Only (Php 994,762.00) (hereinafter called "the Contract Price").

NOW THIS AGREEMENT WITNESSETH AS FOLLOWS:

- iv. Notice of Award of Contract; and the Bidder's conforme thereto; and
- v. Other contract documents that may be required by existing laws and/or the Procuring Entity concerned in the PBDs. Winning bidder agrees that additional contract documents or information prescribed by the GPPB that are subsequently required for submission after the contract execution, such as the Notice to Proceed, Variation Orders, and Warranty Security, shall likewise form part of the Contract.
