## BIDS AND AWARDS COMMITTEE RESOLUTION DECLARING SINGLE CALCULATED AND RESPONSIVE BID AND RECOMMENDING AWARD RESOLUTION NO.: 402 S. 2021

- WHEREAS, the Department of Social Welfare and Development Cordillera Administrative Region (DSWD-CAR) has given appropriations for the Improvement of an Existing Building into Regional Operations Center (ROC) with an Approved Budget for the Contract (ABC) of Three Million Pesos Only (Php3,000,000.00);
- WHEREAS, Republic Act 9184, otherwise known as the Government Procurement Reform Act, in its Implementing Rules and Regulations under Section 10, provides that "all procurement shall be done through competitive bidding, except as provided in Rule XVI";
- WHEREAS, in consonance with the Republic Act 9184 and its Implementing Rules and Regulations, a Project Procurement Management Plan (PPMP) for the project was incorporated in CY2021 Indicative Annual Procurement Plan (APP) of the Field Office adopting Public Bidding as mode of Procurement;
- WHEREAS, the Bids and Awards Committee (BAC) through the BAC Secretariat posted the Invitation to Bid from May 13, 2021 to 9:00 AM of June 1, 2021 at DSWD-CAR website, Philippine Government Electronic Procurement System (PhilGEPS) and posted at DSWD-CAR Bulletin Board located at the main entrance of the Field Office;
- WHEREAS, the Procuring-Entity scheduled a Pre-bid Conference on May 20, 2021 held at DSWD-CAR premises and through Video Conferencing. The said activity was attended by the members of the BAC and its secretariat, and prospective bidders. Among the invited observers, only observers from the Commission on Audit (COA) was able to attend the said activity;
- WHEREAS, in response to the said advertisement, bidders namely ADL GENERAL CONSTRUCTION, and XANDRIX BUILDERS purchased and paid the bidding documents fee. However, on 31st day of May 2021, ADL GENERAL CONSTRUCTION one of the bidders who purchased the bidding documents, submitted its intent to withdraw in participating the bidding at hand. Said withdrawal was due to newly acquired contract from other Procuring Entity and such will consume their resources and may result to non-accommodation of the bidding at hand. Therefore, within the set deadline at 9:00AM of June 1, 2021, only XANDRIX BUILDERS was able to submit their bidding documents;
- WHEREAS, in reference to BAC Resolution No. 375 S.2021, the bid of XANDRIX BUILDERS was declared as the Single Calculated Bid (SCB). Therefore, the BAC decided to subject XANDRIX BUILDERS into a post-qualification stage to verify, validate and ascertain the authenticity of all statements and documents submitted for the project;
- WHEREAS, the Technical Working Group (TWG) composed of 1) Victor U. Bomowey/Procurement Section, 2) Jefferson A. Rodolfo/KC NCDDP, 3) Hamlet C. Mayona/RICTMS, conducted a post-qualification with the said bidder;
