- WHEREAS, the Department of Social Welfare and Development-Cordillera Administrative Region (DSWD-CAR) has been granted appropriations for the BOARD AND LODGING FOR THE PROVINCIAL CONSULTATION AND WORKSHOP FOR THE SOCIAL PENSION PROGRAM IMPLEMENTATION CY 2021- IFUGAO with an Approved Budget for the Contract (ABC) of Seventy-Two Thousand Five Hundred Pesos Only (₱72, 500.00);
- WHEREAS, in consonance with the Republic Act 9184 and its Implementing Rules and Regulations, a Project Procurement Management Plan (PPMP) which has been consolidated into the Annual Procurement Plan (APP) is in order for procurement of the programs, activities and projects for 2021;
- WHEREAS, in consonance with the Republic Act 9184, otherwise known as the Government Procurement Reform Act, in its Implementing Rules and Regulations under Section 10, provides that "all procurement shall be done through competitive bidding, except as provided in Rule XVI";
- WHEREAS, Section 48.1 of the IRR of the above cited act stipulates that "subject to prior approval of the head of procuring entity, and whenever justified by the conditions provided in this Act, the procuring entity may, in order to promote economy and efficiency, resort to any of the alternative mode of procurement;
- WHEREAS, section 53.10 of the Revised Implementing Rules and Regulations (IRR) of the RA 9184 or otherwise known as the Government Procurement Reform Act of 2002 allows the procuring entity to resort to Negotiated Procurement LEASE OF VENUE;
- WHEREAS, on the 13th day of April 2021, Request for Quotations were transmitted to the End-User;
- WHEREAS, on the 21<sup>st</sup> day of April 2021 at 12nn was the set deadline for the submission of quotations wherein three (3) price quotations were obtained from SOUTH VILLE INN, EL KIKASA HOMESTAY, and PEDRALTA HOTEL. In pursuant to the 2016 Revised IRR of RA 9184 under Lease of Venue and Small Value Procurement, the receipt of at least one (1) price quotation is sufficient to proceed with the evaluation thereof;
- WHEREAS, upon opening of the Request for Quotations held on the 10<sup>th</sup> day of April 2021, findings were listed in the summary of quotations below:

- WHEREAS, upon evaluation by the Bids and Awards Committee (BAC), EL KIKASA HOMESTAY emerged to be the lowest bidder. Upon tabulation of the rating factor and due to the non-compliance of the lowest bidder with some of the prescribed provisions, EL KIKASA HOMESTAY did not meet the passing rate of 90% wherein it only garnered 88.50% rating from the End-User. Therefore, the lowest bidder was found to be non-compliant;
- WHEREAS, SOUTH VILLE INN emerged to be the 2<sup>nd</sup> lowest bidder. Upon further assessment, the said bidder was found to be compliant. Moreover, upon tabulation of the rating factor, SOUTH VILLE INN surpassed the 90% passing rate wherein it garnered a 100% rating factor from the End-User;
- WHEREAS, based on the foregoing, the BAC resolved to recommend the award of contract to SOUTH VILLE INN as the Lowest Calculated and Responsive Bidder (LCRB);
- NOW, THEREFORE, foregoing premises considered, We, the Members of the Bids and Awards Committee, hereby RESOLVED as it is hereby resolved to recommend to the Regional Director the award of contract to SOUTH VILLE INN which offered an amount of Seventy Thousand Eight Hundred Ninety Five Pesos Only (₱70,895.00) inclusive of all the applicable taxes and fees for the BOARD AND LODGING FOR THE PROVINCIAL CONSULTATION AND WORKSHOP FOR THE SOCIAL PENSION PROGRAM IMPLEMENTATION CY 2021- IFUGAO.
