PURCHASE OF NFA RICE FOR FAMILY FOOD PACKS**

WHEREAS, the Department of Social Welfare and Development-Cordillera Administrative Region (DSWD-CAR) has been granted appropriations for the **PURCHASE OF NFA RICE FOR FAMILY FOOD PACKS** with an Approved Budget for the Contract (ABC) amounting to **One Million Three Hundred Forty Thousand Pesos Only (P1,340,000.00)**;

WHEREAS, in consonance with the Republic Act 9184 and its Implementing Rules and Regulations, a Project Procurement Management Plan (PPMP) which has been consolidated into the Annual Procurement Plan (APP) is in order for procurement of the programs, activities and projects for 2021;

WHEREAS, in consonance with the Republic Act 9184, otherwise known as the Government Procurement Reform Act, in its Implementing Rules and Regulations under Section 10, provides that "all procurement shall be done through competitive bidding, except as provided in Rule XVI";

WHEREAS, Section 48.1 of the IRR of the above cited act stipulates that "subject to prior approval of the head of procuring entity, and whenever justified by the conditions provided in this Act, the procuring entity may, in order to promote economy and efficiency, resort to any of the alternative mode of procurement;

WHEREAS, upon conduct of Cost Benefit Analysis (CBA), it was found that it will be more economical and efficient if the Procurement Entity will resort to negotiated procurement through **Agency-to-Agency**, the BAC then decided that **Agency-to-Agency** will be the mode of procurement to be used in the procurement at hand;

WHEREAS, on the 14th day of May 2021, Request for Quotation was transmitted to the End-User and a price quotation was obtained from **NATIONAL FOOD AUTHORITY LA UNION BRANCH**;

WHEREAS, **NATIONAL FOOD AUTHORITY** is the only government entity which has the mandate to provide government rice to DSWD, LGUs, and other government agencies for relief operations in times of calamities;

WHEREAS, **NATIONAL FOOD AUTHORITY** submitted a quotation as summarized below:


