The Pantawid Pamilyang Pilipino Program (4Ps) of the Department of Social Welfare and Development - Cordillera Administrative Region (DSWD-CAR) has piloted its Pugay Tagumpay or its graduation program for household (HH) beneficiaries with improved level of well-being in Kalinga, Apayao, and Baguio City.

Pugay Tagumpay is a ceremonial turnover that recognizes and acknowledges the milestones, accomplishments, and the overall improvement of the HH beneficiaries' well-being based on the result of 2019 Social Welfare and Development Indicator (SWDI), an assessment tool that determines the level of economic sufficiency and social adequacy of the family-beneficiaries.

In Pasil, Kalinga, 11 HH beneficiaries were recognized on March 4 with the

"These graduating households are the gains of the Pantawid Pamilya. They have been validated to have established a foundation within their families. We are hoping that they will sustain the self-sufficiency level they attained," DSWD-CAR OIC Regional Director Leo Quintilla said.

# Hard work and Support: The Tamo Family's Foundation By Thefanny G. Borgonia and Bryan B. Villastiqui, MOO - Tayum, Abra

The family of Reynalyn and Bernard Tamo is one of the families from the western part of the Cordillera who solely rely on farming for

Married for 15 years, the couple is blessed with four children whom they consider as their wealth. The family lives in a duplex house made of mixed wood, bamboo, and hollow blocks at the agriculture-producing community of sitio Adammay in Budac, Tayum, Abra.

Prior to becoming a Pantawid Pamilya beneficiary in 2011, Reynalyn admitted that her family has been challenged financially just like other 4Ps families. Oftentimes, their earnings from farming are not enough to sustain their daily living even if they double their efforts.

Despite that, Reynalyn is grateful to have a responsible and supportive husband. Since their inclusion to the program, Bernard never forbids her to attend program monthly meetings and activities. He even encouraged her to become more active in Pantawid Pamilya gatherings.

When Reynalyn was selected as a Parent Leader

(PL) in their cluster, Bernard helped her in performing her duties. The traits exemplified by Bernard has made the family stronger despite financial scarcity.

Although Bernard earned a degree in Marine and Transportation, he was not able to practice his profession because his late father did not allow him to go out of the province, and demanded him a different priority, instead. Because of that, he resorted into farming as the only viable opportunity in their community.

While patiently enduring tilling the land. Reynalyn and Bernard immersed in agriculturerelated training organized by various groups in their community while ensuring that they are compliant with their responsibilities as 4Ps beneficiary.

With the interest to learn more about Agriculture, the Abra Diocesan Teachers and Employees Multi-Purpose Cooperative (ADTEMPCO) invited them to attend a training on Integrated Farming Systems in Baguio City in December 2018. The opportunity has furthered their perspective and interest in farming. They

learned techniques and strategies in planting hybrid vegetables and production of swine and poultry.

After their training, they started to apply Integrated Farming Systems in their farm. This has made their farm better than the usual. With the willingness of Reynalyn and Bernard in adopting the agricultural practices and technologies, the ADTEMPCO provided all the materials and expenses in re-building their farm, even if they are still renting. The Cooperative also provided continuous technical assistance during their early months of engagement. Some Integrated Farming System Technicians from Japan also visited their farm and provided additional inputs in improving their farming skills.

Added to that, the cooperative also offered them start-up capital for their swine and poultry production including the construction of swine and poultry facilities. Their family never hesitated to take the offer even if it is a loan agreement because they believe that they can manage their farm well.

At present, the Tamo family cultivates green beans, eggplant, bitter gourd, squash, bottle gourd, and okra in their farm. They integrated farm scheduling where they plant crops every November and start harvesting from January until March.

The poultry and swine production of the Tamo family is also gradually improving, which greatly augments their income. Recently, they were able to produce 100 heads of ducks, which they sold at 150 pesos per head. They also butchered three heads of pigs weekly with a net income of 1500 per head.

Meanwhile, although Bernard missed his opportunity to become a Marine, he makes use of his education during this time of COVID-19 pandemic in assisting his children in their modular sessions. Reynalyn shared

# A Mother's Meaningful Decision Marlo C. Abyado Jr., Pantawid Pamilya Information Officer, with reports from Janet L .Segundo, PDO II, Provincial GRS Focal- Mt. Province.

Jumelyn bids the Pantawid Pamilya goodbye after opportunities knock on her door, promising a better future for her and for her family.

At 34, Jumelyn is confident that leaving the program is one of the most meaningful decisions her family has ever made despite having still a meager income.

'Agyamanak iti programa a Pantawid Pamilya gapu ta nanglukat daytoy iti addu nga opurtunidad kadakami a pamilya (We are thankful for the Pantawid Pamilya because this opened many opportunities for our family),' Jumelyn Gados gratefully shared.

Just like other families, Jumelyn's family from Poblacion, Tadian, Mountain Province experienced hurdles in life before becoming a program beneficiary, but they stood with hard work and patience after being stumbled from life's turmoil

Jumelyn had her first child when she was in her second year of college. Unplanned, she had to stop her schooling to take care of their child.

Her husband Ricoh, only relies on on-call carpentry labor work back then. They were then left with fear and uncertainty having limited employable skills and scarce financial resources.

It was until the Pantawid Pamilyang Pilipino Program of the Department of Social Welfare and Development became the starting point that gave them opportunities to strive more and work harder. They became a program beneficiary in 2009. Since then, Jumelyn and Ricoh had instilled togetherness, hard work, and patience within their family.

It was through the program that she was able to speak confidently in front of her cobeneficiaries and other people. It also paved the way for her to develop her leadership ability. Jumelyn served as a Parent Leader in her cluster for three years and she received positive feedback from her group members with her energetic and dedicated service.

But before having those qualities, Jumelyn recounted how their life before has affected her confidence.

'Awan unay ti confidence ko idi nga agsao iti sangoanan ti addu a tao. Mabainak a talaga. Ngem idi nag at-attendar kami iti Family Development Session (FDS), nakatulong daytoy iti panang enhance me iti leadership abilities me ken naadal me nga agbalin a boses ti kakadwa me (Because of our poor life, I was not confident to talk infront of many people, I was really shy to speak, back then. But when we were immersed with the monthly FDS of the program, we were motivated to speak and as the voice of our co-parents),' Jumelyn confidently shared.

Moreover, Jumelyn once worked as an Overseas Filipino Worker but fate did not favor her due to some health conditions. Left without enough resources from work abroad. she went back home and pursued a caregiving

course sponsored by the Mountain Province Provincial Local Government Unit.

In 2017, she became a recipient of the Preemployment Assistance Fund (PEAF) under the Sustainable Livelihood Program (SLP) which is another program sof the DSWD Field Office CAR. She was then an applicant as a forest guard at the Department of Environment and Natural Resources. Luckily, she was hired as a Job Order with a daily wage of 295 pesos.

Believing that she has enough skills and the capacity to work with a more stable and decent job, Jumelyn tried her luck as Laboratory Aide at the Luis Hora Memorial Regional Hospital, located in a nearby town from their residence.

In June 2020, at the height of the COVID 19 pandemic, Jumelyn got the same job position as a regular employee of the said hospital with a monthly rate of about 16,000 pesos. Jumelyn admits that her work is really challenging, especially that she is exposed to health risks, but she is grateful to have stable work during this pandemic.

With her regular employment, she immediately consulted the Municipal Operations Office and voluntarily submitted her accomplished and signed waiver from the program.

'Ammuk idi pilang damu nga isu ti patakaran ti programa, ngem malaksid ijay, makitak nga makaya min nga tumakder iti bukod me a saka, ken isu ti ammuk nga rumbeng nga aramiden (I knew at first the policy of the program, but, apart from that, I believe that we can stand on our own, and this is the right thing to do),' Jumelyn said.

Under the program's policy, waiving is done voluntarily. A household also exits from the program when the youngest monitored child in the family reaches the age of 18. Another means is through the Grievance Redress System if the beneficiaries are reported on third offense for misdemeanor acts.

Effective 8 June 2020, the family of Jumelyn was deactivated from the program.

Their children CJ, Rica Cesaria, and Raven, serve as their inspiration that keeps them stronger and going. CJ is now in grade 8, who was then in pre-school when they were registered as Pantawid Pamilya beneficiary. Meanwhile, Rica and Raven are in Grade 7 and Grade 1. The new mode of learning may have challenged their children, but Jumelyn shared that she patiently guides them in their modular sessions, like how she helped her parent group members when she was still a parent leader.

At present, Jumelyn's family has started to build a concrete shelter from their savings. With their combined efforts, her husband is now into hollow blocks making while maintaining a small swine production.

Jumelyn is one of the many faces of women in the Cordillera who have shown a great example of a strong, hardworking, and persevering mother, a wife, and a caregiver. She may earn just enough for the daily needs of her family but she is confident that they make ends meet with hard work, diligence, and staying together. ###

KNOWING THEIR LEVEL OF WELL-BEING. On 2-3 February 2021, PDO III Maria T. that her husband is more patient in teaching their children while instilling discipline through open communication. These are all what they learned from the program.

According to Reynalyn, the program's Family Development Session has elevated their spiritual development as they put God as the center of their family. Since the imposition of General Community Quarantine, Bernard and Reynalyn ensure that their family participates in the home bible study being conducted by their church leaders. According to Reynalyn, one of the most important lessons they learned from the FDS was on financial literacy which they currently apply in their small business.

The couple's first and second children, Franklin and Francis are currently both in Junior High School. The third and fourth, Floyd and Cris, are both in Grade 3 at An-anaao Integrated School. Franklin, Francis, and Floyd

are the currently monitored children under the Pantawid Pamilya.

Despite the threat of the pandemic, the Tamo family is gradually coping with the crisis. In February this year, their lessor allowed them to put-up a sari-sari store and wet market near their farm where they sell their farm products.

Now, they sell their products at a cheaper price compared to the regular market prices as a way of giving their blessings. The decision aims to help the most affected members in their community in this time of pandemic.

Reynalyn and Bernard may still have a long journey to achieve success for their family but they believe that with hard work and support with each other, they will be able to achieve the comfortable and stable life they are longing for. ###

## **4Ps Parent Leaders receive** livelihood assistance from LGU

Sta. Marcela, Apayao - After demonstrating teamwork, malasakit, and dedication in their community, Parent Leader (PL) beneficiaries of the Pantawid Pamilyang Pilipino Program here received livelihood assistance from the Local Government Unit worth 75,000 during the ceremonial turnover held on 21 January 2021 at the town's municipal hall.

The assistance is granted to the PL group in reciprocation of their immeasurable and relentless support and services extended to the LGU and DSWD programs and services before and during the COVID-19 pandemic.

Established in June 2019, the Sta Marcela Parent Leader's Association (SMPLA) has 29 members from the 13 barangays of the municipality. The group envisions to establish an economic opportunity for its members and the community towards self-sustainability and self-sufficiency.

During the ceremonial turnover, Sta. Marcela Municipal Mayor Evelyn B. Martinez recognized the contributions of the 4Ps beneficiaries and affirmed the full support of the LGU to the activities of the association.

"The request should have been a certain amount for the stipend of the Parent Leaders who shared their efforts and time in the municipality. However, the LGU has decided to give livelihood assistance instead because this will help them in the long run. We are hopeful that the assistance would benefit them," Mayor Martinez said.

## DSWD to register 6000 additional **4Ps beneficiaries in CAR**

The Pantawid Pamilyang Pilipino Program of the Department of Social Welfare and Cordillera Administrative Development targeted Region has around 6,000 new beneficiaries through household replacement for set 10 registration.

Pantawid Pamilya Coordinator and Division Chief Fatima D. Florendo pointed out that the new 4Ps household beneficiaries will replace those who have exited from the program.

"We would like to emphasize that the new slots of 4Ps beneficiaries are intended only to replace those exited households and these are not expansion of the program beneficiaries.

We are ensuring also that those who will be included as new household beneficiaries are those eligible poor households based on the Listahanan 2 database," Program Coordinator Florendo said

A household exits the program when the youngest monitored child in the family reaches the age of 18 and/or through the Grievance Redress System if the beneficiaries are reported on third offense for misdemeanor acts like cash cards pawning, using the cards for loan collateral, drug abuse, alcoholism, and

The DSWD CAR has started the validation

process in the barangays and municipalities since September 2020. Aside from the identified list in the listahanan database, a Pantawid Pamilya household beneficiary must have children aged 0-18 years old or a pregnant member at the time of the assessment.

The household must also be able and willing to comply with the program conditionalities that include enrolment and attendance of children aged 4-18 in school, deworming of at least twice a year for children aged 6-14, pre and post-natal check-ups for women, preventive check-ups to children aged 5 and below, and attendance to monthly Family Development Session

As of 31 January 2021, the program monitors 57,770 household beneficiaries for their compliance to program conditions education, health, and nutrition.

Enacted into law under RA 11310 in April 2019, the 4Ps is the government's major poverty alleviation program that invests in health, nutrition, and education of the poor eligible households. These alongside with the psychosocial and psycho-educational component provided through the Family Development Session towards an improved and sustained well-being. ###

With 35 years of experience on social welfare and development, Director Garcia has brought numerous contributions in improving the well-being of communities in areas he served.


Under his leadership during the COVID-19 operations, DSWD FO V was also awarded with the Best Social Amelioration Program Implementation for mega region.






