

## BIDS AND AWARDS COMMITTEE RESOLUTION DECLARING LOWEST CALCULATED RESPONSIVE BID AND RECOMMENDING AWARD RESOLUTION NO.: 650 S.2021

- WHEREAS, the Department of Social Welfare and Development Cordillera Administrative Region (DSWD-CAR) has appropriations for the procurement of the project, Purchase and Delivery of Fortified Fresh Milk for SFP 11<sup>th</sup> Cycle in Abra with an Approved Budget for the Contract (ABC) amounting One Million Six Hundred Eighteen Thousand Six Hundred Fifty Pesos (Php1,618,650.00);
- WHEREAS, Republic Act 9184, otherwise known as the Government Procurement Reform Act, in its Implementing Rules and Regulations under Section 10, provides that "all procurement shall be done through competitive bidding, except as provided in Rule XVI";
- WHEREAS, the Bids and Awards Committee (BAC) through the BAC Secretariat advertised the Invitation to Bid from *July 31, 2021 to 1:00 PM of August 23, 2021* at DSWD-CAR website, Philippine Government Electronic Procurement System (PhilGEPS) and posted at DSWD-CAR Bulletin Board located at the main entrance of the Field Office;
- WHEREAS, in response to the said advertisement, only two (2) bidders purchased bid documents and submitted a bid/proposal within the set deadline for the submission of bids with cut-off time at 1:00pm of 23 August 2021, to wit:

- WHEREAS, in reference to BAC Resolution No. <u>642, s2021</u>, Zenithal-JNA Construction and Supply was declared as Lowest Calculated Bid and subjected for post-qualification by the Technical Working Group (TWG);
- WHEREAS, the TWG conducted post-qualification with the bidder. A post-qualification report was submitted and presented to the BAC on 03 September 2021 by the TWG with the following findings:
  - Legally, technically and financially compliant
  - Compliant to all the terms and conditions required for the project
  - The bidder will provide sticker to the packaging of the goods as "DSWD Goods, Not for Sale" with DSWD logo
    - The bidder provided a packaging and storage area of the goods located at Patuccanay, Tayum, Abra
  - Adhered to the delivery terms and conditions of the project. The bidder also assured to assign one (1) vehicle and 2-3 manpower separate from the vehicle and staff assigned to the previously awarded contracts for SFP projects in Abra
