**WHEREAS**, the Department of Social Welfare and Development - Cordillera Administrative Region (DSWD-CAR) has appropriations for the procurement of the project, **Purchase and Delivery of Food Supplies for SFP 11<sup>th</sup> Cycle in Tabuk City, Kalinga** with an Approved Budget for the Contract (ABC) amounting **Four Million Nine Hundred Ninety-Two Thousand Pesos (Php4,992,000.00)**;

**WHEREAS**, the Bids and Awards Committee (BAC) through the BAC Secretariat advertised the Invitation to Bid from **July 31, 2021 to 9:30 AM of August 13, 2021** at DSWD-CAR website, Philippine Government Electronic Procurement System (PhilGEPS) and posted at DSWD-CAR Bulletin Board located at the main entrance of the Field Office;

**WHEREAS**, the Procuring-Entity scheduled a **Negotiated Conference** on **August 6, 2021** held through Video Conference/Google Meet. None among the invited observers from Philippine Chamber of Commerce Industry, Jaime V. Ongpin Foundation, Blessed Association of the Retired Persons Foundation, Commission on Audit attended the activity. Two (2) prospective bidders attended the conference namely Zenithal-JNA Construction and Supply and Atipse Marketing and General Merchandise;

**WHEREAS**, in response to the said advertisement, one (1) bidder from **Atipse Marketing and General Merchandise** participated and submitted its bid/proposal within the set deadline for the submission of bids with cut-off time at 9:30am of August 13, 2021;

**WHEREAS**, the BAC conducted the opening of bids scheduled at 10:00am on August 13, 2021 at DSWD Training Center and attended by the BAC members including its Secretariat. 
