


Failure to provide the performance security shall constitute sufficient ground for cancellation of the award and forfeiture of the bid security.

RESOLUTION NO.: 297**

WHEREAS, the Department of Social Welfare and Development - Cordillera Administrative Region (DSWD-CAR) has appropriations for the project, **Upgrading of Electrical Capacity of DSWD-CAR Field Office Buildings** with an Approved Budget for the Contract amounting to **One Million Eight Hundred Nineteen Thousand Seven Hundred Seventy Nine Pesos and 62/100 (Php1,819,779.62)**;

WHEREAS, Republic Act 9184, otherwise known as the Government Procurement Reform Act, in its Implementing Rules and Regulations under Section 10, provides that "all procurement shall be done through competitive bidding, except as provided in Rule XVI";

WHEREAS, in consonance with the Republic Act 9184 and its Implementing Rules and Regulations, a Project Procurement Management Plan (PPMP) for the project was incorporated and consolidated in the CY2020 Annual Procurement Plan (APP) of the Field Office adopting Public Bidding as mode of Procurement;

WHEREAS, the Bids and Awards Committee (BAC) through the BAC Secretariat advertised the Invitation to Bid from **May 14, 2020 to June 3, 2020** at DSWD-CAR website, Philippine Government Electronic Procurement System (PhilGEPS) and posted at DSWD-CAR Bulletin Board located at the main entrance of the Field Office;

WHEREAS, in reference to **BAC Resolution No. 271, s2020**, **Leo Heirs Construction** was declared as a **Single Calculated Bid** and subjected for post-qualification by the Technical Working Group (TWG);

WHEREAS, the TWG conducted post-qualification with the bidder on July 3, 2020;

WHEREAS, the TWG also conducted verification to the Municipal Engineer of LGU Lagawe, Ifugao to confirm the previous contract awarded to the bidder that was declared under the SLCC and was only contacted on July 9, 2020;

WHEREAS, the TWG submitted their findings and recommendation on July 10, 2020 as a result of Post-qualification conducted and presented to the BAC the following:

- Legally, technically and financially responsive
- With enough resources and NFCC to undertake the project
- Has the necessary tools and equipment needed for the project
- Has accepted the bid amount as calculated which is lower as against the bid amount **as read**
- Availability of key personnel is dependent on the existence of a project
- Performed satisfactorily on previous completed contract with LGU Lagawe, Ifugao **as confirmed** by the OIC-Municipal Engineer.
