BIDS AND AWARDS COMMITTEE BAC RESOLUTION DECLARING LOWEST CALCULATED RESPONSIVE BID AND RECOMMENDING AWARD RESOLUTION NO.: 039 s.2020

- WHEREAS, the Department of Social Welfare and Development Cordillera Administrative Region (DSWD-CAR) has appropriations for the Outsourcing of Service Provider for the Security Services to DSWD Field Office, Training Center and Other Facilities for 2020 (ITB 2020-DSWD-CAR-01) with an Approved Budget for the Contract (ABC) amounting to Five Million One Hundred Fifty Eight Thousand Five Hundred Pesos (Php 5,158,500.00);
- WHEREAS, Republic Act 9184, otherwise known as the Government Procurement Reform Act, in its Implementing Rules and Regulations under Section 10, provides that "all procurement shall be done through competitive bidding, except as provided in Rule XVI";
- WHEREAS, the Bids and Awards Committee (BAC) through the BAC Secretariat advertised the Invitation to Bid from November 12, 2019 to December 2, 2019 through Competitive Bidding;
- WHEREAS, there are two (2) bidders signified interest and purchased bid documents from Power Plus Security and Investigations Services, Corp. and Quality Guards Services and Investigation Services Corp.;
- WHEREAS, Power Plus Security and Investigations Services, Corp. was declared by the BAC as the Lowest Calculated Bid having found Legally, Technically and Financially compliant and passed all the criteria stated in the eligibility requirements with bid amount of Four Million Seven Hundred Seventy Two Thousand Two Hundred Three Pesos and 44/100 (Php4,772,203.44);
- WHEREAS, Power Plus Security and Investigations Services, Corp. was Post-Disqualified for non-submission of Income and Business Tax Returns filed through the BIR Electronic Filing and Payment System (EFPS) wherein the bidder submitted a manually filed Income and Business Tax Returns which is not compliant to the requirement stated in the Philippine Bidding Documents Section 29.2 and as indicated in the Bid Data Sheet ITB Clause 29.2;
- WHEREAS, Power Plus Security and Investigations Services, Corp. was given three (3) calendar days to file a Motion for Reconsideration for failure to pass all the criteria for Post-Qualification;
- WHEREAS, in reference to BAC Resolution 2020-18, Power Plus Security and Investigations Services, Corp. submitted a Motion for Reconsideration dated December 30, 2019 but the BAC unanimously denied the Motion for Reconsideration;
- WHEREAS, the Technical Working Group conducted post-qualification to the next lowest bidder, Quality Guards Services and Investigation Agency, Inc. on January 20, 2020 and found the following:
 - Legally, Technically and Financially Compliant
 - With enough NFCC to undertake the project
 - With Income and Business Tax Returns filed through EFPS
 - Most of the completed contracts in CY2018 were renewed in CY2019
 - With available ammunitions and other paraphernalia as required for the project
 - Performed satisfactorily as a service provider at DSWD-CAR and no derogatory complain against them per interview with the end-user and DSWD officer
 - Compliant to DOLE DO. 150, s2016 and DOLE DO. 174, s2017 to other contracts from other government and private entities except at DSWD-CAR wherein the new daily wage rate of P350.00 per day is not yet in effect for December 2019 payroll. The bidder clarified that the underpayment was already cleared to the security guards as a back pay and to be paid once the payment from DSWD will be received by them.

WHEREAS, the Post-Qualification Report was presented to the BAC and the end-user clarified that the new wage order was already effected in the payment. The December 2019 billing statement of Quality Guards Services and Investigation Agency, Inc. was processed but included in the Accounts Payable;

WHEREAS, the BAC deliberated whether to accept the disposition of Quality Guards Services and Investigation Agency, Inc. that the increase of daily wage rate of DSWD-CAR security guards will be paid as a back pay once the said security agency received the payment from DSWD-CAR;

WHEREAS, the BAC accepted the reason of the bidder subject to the condition that the bidder shall submit a proof of payment to the underpaid new daily wage rate of DSWD security guards in compliance with DOLE Daily Minimum Wage Rate per Wage Order No. RB-CAR-20 and directed the end-user to monitor such;

WHEREAS, the BAC unanimously declared Quality Guards Services and Investigation Agency, Inc. as the Lowest Calculated Responsive Bidder for passing the criteria for Post-Qualification;

NOW, THEREFORE, we, members of the Bids and Awards Committee, hereby RESOLVE as it is hereby RESOLVED to:

- Declare the bid of Quality Guards Services and Investigation Agency, Inc. as the Lowest Calculated and Responsive Bid (LCRB),
- Recommend to the Head of Procuring Entity (HOPE) the award of contract to Quality Guards Services and Investigation Agency, Inc. the project, Outsourcing of Service Provider for the Security Services to DSWD Field Office, Training Center and Other Facilities for 2020 under ITB 2020-DSWD-CAR-01 with contract amount of Four Million Nine Hundred Sixty Two Thousand Five Hundred Pesos and 04/100 (Php4,962,500.04);
