

**WHEREAS,** the Department of Social Welfare and Development - Cordillera Administrative Region (DSWD-CAR) has appropriations for the project, **Hire of Trucks for the Delivery of Food and Non-Food Items within Cordillera** with an Approved Budget for the Contract amounting to **Four Million Nine Hundred Seventy One Thousand Pesos (Php4,971,000.00)**;

**WHEREAS,** Republic Act 9184, otherwise known as the Government Procurement Reform Act, in its Implementing Rules and Regulations under Section 10, provides that "all procurement shall be done through competitive bidding, except as provided in Rule XVI";

**WHEREAS,** in consonance with the Republic Act 9184 and its Implementing Rules and Regulations, a Project Procurement Management Plan (PPMP) for the project was incorporated and consolidated in the CY2020 Annual Procurement Plan (APP) of the Field Office adopting Public Bidding as mode of Procurement;

**WHEREAS,** the Bids and Awards Committee (BAC) through the BAC Secretariat advertised the Invitation to Bid from **July 9, 2020 to July 29, 2020** at DSWD-CAR website, Philippine Government Electronic Procurement System (PhilGEPS) and posted at DSWD-CAR Bulletin Board located at the main entrance of the Field Office;

**WHEREAS,** only one (1) bidder submitted bid/proposal on July 29, 2020 namely **M.G. Serrano Enterprise** from Pampanga;

**WHEREAS,** in reference to **BAC Resolution No. 344, s2020, M.G. Serrano Enterprise** was declared as a **Single Calculated Bid** and subjected for post-qualification by the Technical Working Group (TWG);
