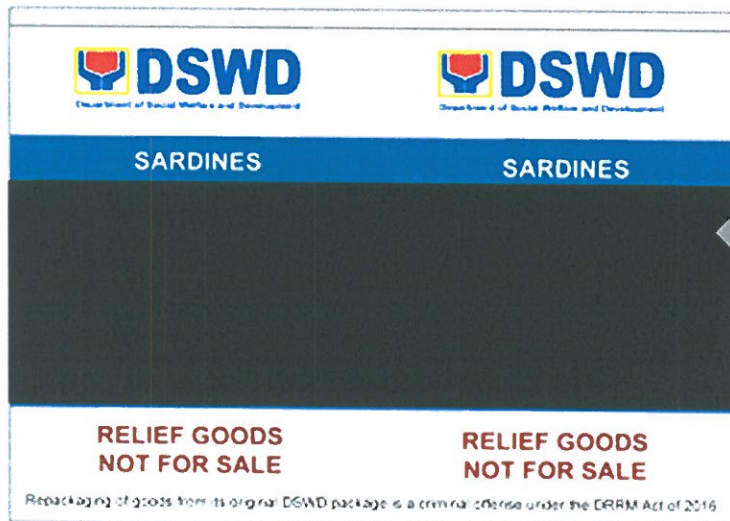
Proposed Labelling/Markings for Canned Goods:

a. Canned Corned Beef



In this area, the winning bidder may have the option to place their branding and product imaging.

b. Canned Sardines



In this area, the winning bidder may have the option to place their branding and product imaging.

NOTE:

1. The winning bidder must ensure that the printing of the above lay-out will not violate Republic Act 8293 (Intellectual Property Code of the Philippines) and DSWD Branding Guidelines.
2. Final sample should be provided by the winning bidder prior to mass production of the goods.
3. The winning bidder shall provide a sample for approval of the Procuring Entity **within five (5) working days upon receipt of the Notice to Proceed.**
