

INVITATION TO BID
Purchase of Perishable and Non-Perishable Food Supplies for Supplementary Feeding Program in Rizal, Tabuk, Tanudan, Pinukpuk, Balbalan and Pasil, Kalinga

1. The *Department of Social Welfare and Development - Cordillera Administrative Region (DSWD-CAR)*, through the *Direct Release*³ intends to apply the sum of *Lot 1: Four Million Nine Hundred Fifty Nine Thousand Seven Hundred Ninety Six Pesos and 25/100 (Php 4,959,796.25)* and *Lot 2: Three Million Eight Hundred Sixty Seven Thousand Seven Hundred Three Pesos and 75/100 (Php 3,867,703.75)* being the Approved Budget for the Contract (ABC) to payments under the contract for *ITB No. 2019-DSWD-CAR-007*. Bids received in excess of the ABC shall be automatically rejected during the bid opening.

Delivery of the Goods is required every 1st and 3rd Monday of the month for Rizal, Tabuk, Pinukpuk while every first Monday of the month for Tanudan, Balbalan, Pasil from July to December 2019 for Lot 1 and July 1, 2019 and September 30, 2019 for Lot 2. Bidders should have completed, within Two (2) years from the date of submission and receipt of bids, a contract similar to the Project. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II. Instructions to Bidders.

3. Bidding will be conducted through open competitive bidding procedures using a non-discretionary “pass/fail” criterion as specified in the 2016 Revised Implementing Rules and Regulations (IRR) of Republic Act (RA) 9184, otherwise known as the “Government Procurement Reform Act”.
- (i) Bidding is restricted to Filipino citizens/sole proprietorships, partnerships, or organizations with at least sixty percent (60%) interest or outstanding capital stock belonging to citizens of the Philippines, and to citizens or organizations of a country the laws or regulations of which grant similar rights or privileges to Filipino citizens, pursuant to RA 5183.
4. Interested bidders may obtain further information from **Department of Social Welfare and Development - Cordillera Administrative Region (DSWD-CAR)** and inspect the Bidding Documents at the address given below during **8:00AM to 5:00PM**.
5. A complete set of Bidding Documents may be acquired by interested Bidders on **8:00 AM of April 26, 2019 to May 20, 2019 at 8:45 AM, PST** from the address below and upon payment of the applicable fee for the Bidding Documents, pursuant to the latest Guidelines issued by the GPPB, in the amount of **Five Thousand Pesos (Php 5,000.00) for each lot**.

It may also be downloaded free of charge from the website of the Philippine Government Electronic Procurement System (PhilGEPS) and the website of the Procuring Entity, provided that Bidders shall pay the applicable fee for the Bidding Documents not later than the submission of their bids.
6. The **Department of Social Welfare and Development - Cordillera Administrative Region (DSWD-CAR)** will hold a Pre-Bid Conference⁵ at **9:30 AM, PST of May 6, 2019** at the **Office of the Assistant Regional Director for Administration, DSWD-CAR, 40 North Drive Baguio City**, which shall be open to prospective bidders.
7. Bids must be duly received by the BAC Secretariat at the address below on or before **8:45 AM, PST of May 20, 2019**. All Bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in ITB Clause 18.

Bid opening shall be on **9:00 AM, PST of May 20, 2019** at the **Office of the Assistant Regional Director for Administration, DSWD-CAR, 40 North Drive Baguio City**.

Bids will be opened in the presence of the bidders' representatives who choose to attend at the address below. Late bids shall not be accepted.

The *Department of Social Welfare and Development - Cordillera Administrative Region (DSWD-CAR)* reserves the right to reject any and all bids, declare a failure of bidding, or not award the contract at any time prior to contract award in accordance with Section 41 of RA 9184 and its IRR, without thereby incurring any liability to the affected bidder or bidders.
