

Invitation to Bid for the Construction of Day Care Center and Senior Citizen Center in Labaan, Bucloc, Abra (2nd Posting) ITB No.: 2019-DSWD-CAR-008

1. The *Department of Social Welfare and Development - Cordillera Administrative Region (DSWD-CAR)*, through the *Protective Services Program Fund* intends to apply the sum of *One Million Eight Hundred Thousand Pesos (Php 1,800,000.00)* being the Approved Budget for the Contract (ABC) to payment under the contract for *Construction of Day Care Center and Senior Citizen Center in Labaan, Bucloc, Abra (2nd Posting)*.

Bids received in excess of the ABC shall be automatically rejected at bid opening.

2. The *Department of Social Welfare and Development - Cordillera Administrative Region (DSWD-CAR)*, now invites bids for the *Construction of Day Care Center and Senior Citizen Center in Labaan, Bucloc, Abra (2nd Posting)*.
Completion of the Works is required *within Ninety (90) calendar days (simultaneous) after receipt of the Notice to Proceed*. Bidders should have completed a contract similar to the Project. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II. Instructions to Bidders.
3. Bidding will be conducted through open competitive bidding procedures using non-discretionary “pass/fail” criterion as specified in the 2016 Revised Implementing Rules and Regulations (IRR) of Republic Act 9184 (RA 9184), otherwise known as the “Government Procurement Reform Act.”
Bidding is restricted to Filipino citizens/sole proprietorships, cooperatives, and partnerships or organizations with at least seventy-five percent (75%) interest or outstanding capital stock belonging to citizens of the Philippines.--
4. Interested bidders may obtain further information from *Department of Social Welfare and Development - Cordillera Administrative Region (DSWD-CAR)* and inspect the Bidding Documents at the address given below from **8:00AM to 5:00PM**.
5. A complete set of Bidding Documents may be acquired by interested bidders from **8:00 AM of April 26, 2019 to 1:00 PM, PST of May 20, 2019** from the address below *and upon payment of the applicable fee for the Bidding Documents, pursuant to the latest Guidelines issued by the GPPB in the amount of Five Thousand Pesos (Php 5,000.00)*.

6. It may also be downloaded free of charge from the website of the Philippine Government Electronic Procurement System (PhilGEPS) and the website of the Procuring Entity, provided that bidders shall pay the applicable fee for the Bidding Documents not later than the submission of their bids.
 7. The *Department of Social Welfare and Development - Cordillera Administrative Region (DSWD-CAR)* will hold a Pre-Bid Conference on **May 6, 2019 (1:00 PM, PST)** at **DSWD-CAR, 40 North Drive, Baguio City**, which shall be opened to prospective bidders.
 8. Bids must be duly received by the BAC Secretariat at the address below on or before **May 20, 2019 (1:00 PM, PST)**. All bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in **ITB Clause 18**.
 9. Bid opening shall be on **May 20, 2019 (1:30 PM, PST)** at the **DSWD-CAR, 40 North Drive, Baguio City**. Bids will be opened in the presence of the bidders' representatives who choose to attend at the address below. Late bids shall not be accepted.
 10. The *Department of Social Welfare and Development - Cordillera Administrative Region (DSWD-CAR)* reserves the right to reject any and all bids, declare a failure of bidding, or not award the contract at any time prior to contract award in accordance with Section 41 of RA 9184 and its IRR, without thereby incurring any liability to the affected bidder or bidders.
