

INVITATION TO BID FOR
Purchase of Perishable and Non-Perishable Food Supplies
for Supplementary Feeding Program in Benguet

1. The Department of Social Welfare and Development - Cordillera Administrative Region (DSWD-CAR), through the General Appropriations Act for CY 2019³ intends to apply the sum of Lot 1: One Million Eight Thousand One Hundred Thirty Four Pesos and 70/100 (Php 1,008,134.70) Lot 2: One Million Three Hundred Eighty Six Thousand Seven Hundred Ninety Five Pesos (Php 1,386,795.00) Lot 3: Two Million Four Hundred Ninety Nine Thousand Nine Hundred Fifty Pesos and 15/100 (Php 2,499,950.15) and Lot 4: Two Million Three Hundred Twelve Thousand Eight Hundred Sixty Five Pesos and 30/100 (Php 2,312,865.30) Lot 5: Three Million Two Hundred Seventy Nine Thousand Seven Hundred Five Pesos (Php 3,279,705.00) and Lot 6: Two Million Five Hundred Ninety Four Thousand Forty Nine Pesos and 85/100 (Php 2,594,049.85) being the Approved Budget for the Contract (ABC) to payments under the contract for **ITB No. 2019-DSWD-CAR-09**. Bidders should have completed, *within Two (2) years* from the date of submission and receipt of bids, a contract similar to the Project. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II. Instructions to Bidders.

3. Bidding will be conducted through open competitive bidding procedures using a non-discretionary “pass/fail” criterion as specified in the 2016 Revised Implementing Rules and Regulations (IRR) of Republic Act (RA) 9184, otherwise known as the “Government Procurement Reform Act”.
 - (i) Bidding is restricted to Filipino citizens/sole proprietorships, partnerships, or organizations with at least sixty percent (60%) interest or outstanding capital stock belonging to citizens of the Philippines, and to citizens or organizations of a country the laws or regulations of which grant similar rights or privileges to Filipino citizens, pursuant to RA 5183.
4. Interested bidders may obtain further information from *Department of Social Welfare and Development - Cordillera Administrative Region (DSWD-CAR)* and inspect the Bidding Documents at the address given below during **8:00AM to 5:00PM**.
5. A complete set of Bidding Documents may be acquired by interested Bidders on **8:00 AM of May 11, 2019 to June 3, 2019 at 8:45 AM, PST** from the address below and upon payment of the applicable fee for the Bidding Documents, pursuant to the latest Guidelines issued by the GPPB, in the amount of **Five Thousand Pesos (Php 5,000.00) for each lot**.

It may also be downloaded free of charge from the website of the Philippine Government Electronic Procurement System (PhilGEPS) and the website of the Procuring Entity, provided that Bidders shall pay the applicable fee for the Bidding Documents not later than the submission of their bids.

6. The *Department of Social Welfare and Development - Cordillera Administrative Region (DSWD-CAR)* will hold a Pre-Bid Conference⁵ on **10:30 AM, PST of May 20,**

7. Bids must be duly received by the BAC Secretariat at the address below on or before **8:45 AM, PST of June 3, 2019**. All Bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in ITB Clause 18.

Bid opening shall be on **9:00 AM, PST of June 3, 2019** at the **DSWD Training Center, between Leonard Wood Road and Engineer's Hill, Baguio City**. Bids will be opened in the presence of the bidders' representatives who choose to attend at the address below. Late bids shall not be accepted.

8. The **Department of Social Welfare and Development - Cordillera Administrative Region (DSWD-CAR)** reserves the right to reject any and all bids, declare a failure of bidding, or not award the contract at any time prior to contract award in accordance with Section 41 of RA 9184 and its IRR, without thereby incurring any liability to the affected bidder or bidders.
