

**INVITATION TO BID**  
**Purchase of Food Supplies for Supplementary Feeding Program in Flora, Luna, Sta. Marcela and Pudtol, Apayao (2nd Posting)**  
**ITB No.: 2019-DSWD-CAR-016**

1. The Department of Social Welfare and Development - Cordillera Administrative Region (DSWD-CAR), through the General Appropriations Act for 2019<sup>3</sup> intends to apply the sum of **Lot 1: One Million Three Hundred Thirty Nine Thousand Four Hundred Thirty Five Pesos (Php 1,339,435.00), Lot 2: Seven Hundred Four Thousand Seventy Five Pesos (Php 704,075.00), and Lot 3: Four Hundred Twenty Three Thousand Nine Hundred Ninety Pesos (Php 423,990.00)** being the Approved Budget for the Contract (ABC) to payments under the contract for **ITB No. 2019-DSWD-CAR-016**. Bids received in excess of the ABC shall be automatically rejected during the bid opening.

2. The *Department of Social Welfare and Development - Cordillera Administrative Region (DSWD-CAR)* now invites bids for the *Purchase of Food Supplies for Supplementary Feeding Program in Flora, Luna, Sta. Marcela and Pudtol, Apayao (2nd Posting)*.<sup>4</sup>

Delivery of the Goods is required for *Lot 1 and Lot 3: Weekly from August 5 to December 2019 and Lot 2: August 5, 2019.*

Bidders should have completed, *within Two (2) years* from the date of submission and receipt of bids, a contract similar to the Project. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II. Instructions to Bidders.

3. Bidding will be conducted through open competitive bidding procedures using a non-discretionary “pass/fail” criterion as specified in the 2016 Revised Implementing Rules and Regulations (IRR) of Republic Act (RA) 9184, otherwise known as the “Government Procurement Reform Act”.

(i) Bidding is restricted to Filipino citizens/sole proprietorships, partnerships, or organizations with at least sixty percent (60%) interest or outstanding capital stock belonging to citizens of the Philippines, and to citizens or organizations of a country the laws or regulations of which grant similar rights or privileges to Filipino citizens, pursuant to RA 5183.

4. Interested bidders may obtain further information from the *Department of Social Welfare and Development - Cordillera Administrative Region (DSWD-CAR)* and inspect the Bidding Documents at the address given below from **Monday to Friday, 8:00AM to 5:00PM**.

5. A complete set of Bidding Documents may be acquired by interested Bidders on **8:00 AM of June 25, 2019 to 9:30 AM, PST of July 15, 2019** from the address below and upon payment of the applicable fee for the Bidding Documents, pursuant to the latest Guidelines issued by the GPPB, in the amount of **Five Thousand Pesos (Php 5,000.00) for Lot 1; One Thousand Pesos (Php 1,000.00) for Lot 2, Five Hundred Pesos (Php 500.00) for Lot 3 and Five Thousand Pesos for all lots or two (2) lots only**.

It may also be downloaded free of charge from the website of the Philippine Government Electronic Procurement System (PhilGEPS) and the website of the Procuring Entity, provided that Bidders shall pay the applicable fee for the Bidding Documents not later than the submission of their bids.

6. The *Department of Social Welfare and Development - Cordillera Administrative Region (DSWD-CAR)* will hold a Pre-Bid Conference<sup>5</sup> on **03 July 2019 at 10:00 AM, PST at the Office of the Assistant Regional Director for Administration, DSWD-CAR, 40 North Drive Baguio City**, which shall be opened to prospective bidders.

7. Bids must be duly received by the BAC Secretariat at the address below on or before **15 July 2019 at 9:30 AM, PST**. All Bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in ITB Clause 18.

Bid opening shall be on **15 July 2019 at 10:00 AM, PST** at the **Office of the Assistant Regional Director for Administration, DSWD-CAR, 40 North Drive Baguio City**. Bids will be opened in the presence of the bidders' representatives who choose to attend at the address below. Late bids shall not be accepted.

8. The **Department of Social Welfare and Development - Cordillera Administrative Region (DSWD-CAR)** reserves the right to reject any and all bids, declare a failure of bidding, or not award the contract at any time prior to contract award in accordance with Section 41 of RA 9184 and its IRR, without thereby incurring any liability to the affected bidder or bidders.
