1. Approved Budget for the Contract of ITB No. 2018-DSWD-CAR-09 (P 2, 600, 000.00)	
Sir Enrique raised a concern regarding the anticipated failure of the Bid because the estimated cost of the project that was projected last year was different with the present cost since prices of commodities increase.	Sir Enrique said to Sir Angel that the Scope of the project should be revised. He suggested that Engineers should convene and discuss on what to reduce or adjust in order for some cost to decrease. Sir Angel noted for the revision of plan by Sir Richmond before posting the Bid on Wednesday next week. He said that Sir Richmond should reflect the concrete plan for the Project. Sir Richmond should plan per site (materials and area of the building).
	Sir Enrique recognized the suggestion of Sir Javier that instead of using metals for some

	Sir Angel and Sir Javier discussed the possible changes in the plan for Sir Richmond to reflect in the final plan.
2. Accessibility of the Construction Site at Tue	
Sir Victor wasn't sure if the Construction site at Tue is accessible or if it is along the road. Sir Enrique expected that Sir Javier and Sir Richmond already inspect the site but unfortunately they were not able to go because there was no available vehicle.	Sir Angel suggested for site inspection not only in Tue but also the other sites for the project. Then Sir Enrique suggests to ask the help of the Kalahi Engineer, Mr. Gemuel since the project site is a Kalahi Area. Sir Victor also suggested to coordinate with the MS since they know the area well.
-	Sir Angel said that after contacting Mr. Gemuel, he will be the one to estimate the hauling on how far the sites are.
•	Sir Enrique and Sir Angel asked the help of Ma'am Jennifer, as one of the End-user, to contact the right person at the sites.
